TRIP PROTECTION PLAN: We **STRONGLY RECOMMEND** that you purchase a Travel Protection Plan. We have found that the company listed below covers terrorism (you would have to get the guidelines from them). **In order to have this coverage, you must arrange for your coverage within 14 days after deposit has been processed by KI;** otherwise the standard coverage will apply. We are not insurance agents and therefore you would need to contact STA (or a company of your choice) directly for all information. You should know that there are many different types of insurance available. At the very least, it is suggested that you get coverage for medical and/or emergency evacuation in case of illness. This would not cover you for the cost of reimbursement of your air/land package. STA can provide coverage only to those residing in the USA. KI receives no monies from STA and provides this information simply as a courtesy.

DOMESTIC AIRFARE:

At the time of printing, we are planning on using US Airways out of Philadelphia for this tour. If this airline (not a code share flight) flies from your home city, we will be able to obtain a quote for the air add-on.. If they do not, Sharon Stolebarger, Tour Coordinator, will be able to assist you with obtaining domestic air. Domestic airfare is not included in the tour price. At times we change the airline if it is advantageous for the group. If you are providing your own domestic air, you will assume financial responsibility should you purchase a ticket and the international gateway city changes, incurring a penalty to change air cities.

MISCELLANEOUS INFORMATION:

- Registrations are taken on a first-come-first served basis. They must be accompanied by a non-refundable deposit (see above for amount), Registration Form and signed Waiver. **This tour is limited to 30 participants, including the leaders!**
- Daily Itinerary: A day-by-day itinerary will not be available until time of documentation (approximately 30 days prior to departure). All sites to be visited are listed in the brochure.
- Per the Terms and Conditions, children under the age of 15 are not accepted on the Talmidim Tour.
- Passports must be valid SIX MONTHS from the DATE OF RETURN to your original departure point
- Please see Terms and Conditions for all other information, including payment schedule.

INTERNATIONAL PARTICIPANTS:

- Airfare will not be included in your tour package. Your land package will be reduced by \$1100.00. You would then arrange for your own air and meet us in Tel Aviv. You would need to contact Sharon Stolebarger to get the travel schedule. All prices quoted are in US dollars.
- Final payments can either be by check (made out in US dollars), credit card (see higher pricing), or you can now wire transfer funds. Information will be provided upon request.

BEREAN TOUR ADD-ON

The Berean Tour will be May 8 – 18, 2010. If you would like, you can sign up for both tours and pay just one airfare (plus tour package prices). The add-on for this would be \$2895 per person when paying by check, cash, or wire transfer. The cost, when paying by credit card, is \$3012 per person. All prices quoted are per person and based on double occupancy (two to a room). The single supplement (should you not have a roommate) would be an additional \$674 per person (check/cash/wire transfer) or \$695 when paying by credit card.

In order to take advantage of this, simply check the box above, indicating you want to add-on the Berean Tour. You will only need to pay one deposit per person. You will then receive an invoice showing both tours.
