DOMESTIC AIRFARE:

We are using Continental Airlines for this tour. If Continental Airlines (not a code share flight) flies from your home city, we will be able to obtain a quote for the air add-on from Continental. If they do not, Sharon Stolebarger, Tour Coordinator, will be able to assist you with obtaining domestic air. Domestic airfare is not included in the tour price.

MISCELLANEOUS INFORMATION:

- Registrations are taken on a first-come-first served basis. They must be accompanied by a \$570 non-refundable deposit, Registration Form and signed Waiver.
- Daily Itinerary: A day-by-day itinerary will not be available until time of documentation (approximately 30 days prior to departure). All sites to be visited are listed in the brochure.
- Per the Terms and Conditions, children under the age of 7 are not accepted on this tour.
- Passports must be valid **SIX MONTHS** from the **DATE OF RETURN** to your original departure point

INTERNATIONAL PARTICIPANTS:

- Airfare and Travel Protection will not be included in your tour package. Your land package will be reduced by \$1570.00. You would then arrange for your own air and meet us in Tel Aviv. Per our current schedule (subject to change), the group will arrive in Tel Aviv on May 19, 2009 at 4:00pm and will depart Tel Aviv on May 27 at 11:50pm. Should your schedule not coincide with the group, you will be given information on transportation and/or extra nights, as needed, in the hotel(s). All prices quoted are in US dollars.
